Article 1

OBJECTIVE OF COLLABORATION

Article 2

SCOPE OF COLLABORATION

- b. Organizing seminars/webinars/conferences/symposia through blended mode (online and offline).
- c. Sharing of scientific information on areas of mutual interest.
- d. Academic quality-based collaboration, including publications and internships.

Article 3

FINANCIAL ARRANGEMENT

Any collaboration under this MOU is subject to the availability of funding sources and approval of the relevant authorities.

Article 4

LOCATION OF ACTIVITIES

 The Parties agree to implement the programmes stated in Article 2 at Al-Ameen Memorial Minority College and Allama Iqbal Institute Of Culture.

Article 5

CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION

Both the institutions shall respect and retain confidentiality in each/any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the institutions, and not any other/commercial interest. This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

Article 6

DURATION AND TERMINATION

1) This MOU shall enter into force on the date of signing.

 The MOU shall remain in force for a period of 4 years and may be extended for another period of four(4) years by the mutual written consent of the Parties.

3) Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of the termination.

4) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.
