Article 1

OBJECTIVE OF COLLABORATION

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Al-Ameen Memorial Minority College and Roushan Ali Smriti Academy

Article 5

CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION

Both the institutions shall respect and retain confidentiality in each/any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the institutions, and not any other/commercial interest.

This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

Article 6


DURATION AND TERMINATION
