2. Restricted and optimal utilization of water is ensured by using overflow indicators in water tanks.
3. Various activities are organized to sensitize and educate students, teachers, staff and the local community about the importance of water and the methods to conserve it.
4. Installation of water efficient fixtures such as low-flow toilets, faucets and showers to reduce water usage.
5. Regularly inspect and maintain plumbing systems to detect leaks promptly and repair them to prevent water loss.
6. Encouragement of mindful Wudu (Ablution) practices that adhere to Islamic guidelines while minimizing water wastage and emphasizing the importance of performing Wudu properly without excessive use of water.
