FUNDAMENTAL RIGHTS OF MINORITIES



ARTICLE-30 OF INDIAN CONSTITUTION

1. All minorities, based on religion or language, shall have the right to establish & administer educational institutions of their choice.
2. The state shall not, in granting aid to educational institutions, discriminate against any educational institution on the ground that it is under the management of a minority, whether based on religion or language.

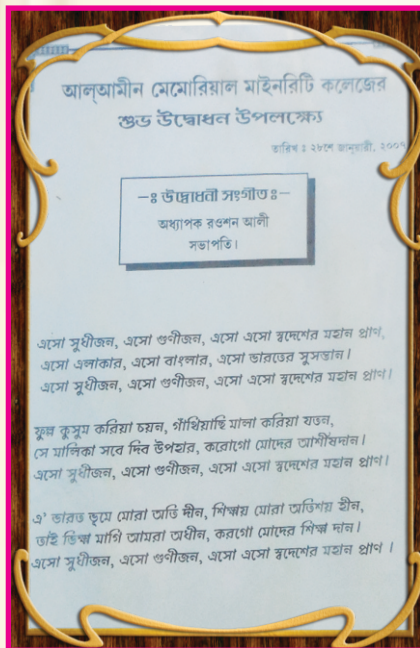

From the Principal's Desk

Dear students,

HOW THE COLLEGE WAS BORN AND BROUGHT UP

Al-Ameen Memorial Minority College is a notably noble achievement of the Al-Ameen Memorial Society for Education & Health Programme. It was founded in the year 2004. The College is a brain - child of its founder, Late Prof. Md. Roushan Ali, a patron of letters, a far-sighted and noble hearted philanthropist. The impediment of his old age did not stand on his way to till his demise to offer encouragement and valuable suggestions every now and then to the founder Secretary of the College Prof. Dr. Nurul Haque to bring it to its full flaged state.

With an aim to imparting education (Higher Education) among the educationally backward minorities of West Bengal but not to the exclusion of the students of other communities, the Society humbly prayed to the Govt. of West Bengal for according necessary permission to the establishment of a Minority College under the **Article 30 of the Constitution**. The state Govt. after necessary verification and with the kind recommendation of the Hon'ble **National Commission for Minority Educational Institutions**, New Delhi, kindly accorded requisite permission to the establishment of the College with Minority status vide W.B. Govt. Order No. 421-Edn(CS)/4C-50/05, dated 26/04/2007. Subsequently the Minority Status Certificate was also issued by the NEMEI in 2008

We are very much happy to apprise that Al-Ameen Memorial Minority College is the **first Muslim Minority General Degree College of West Bengal. It is affiliated to the University of Calcutta**. It is a co-educational institution for higher learning. The College was included Under Section 2(f) of the UGC act, 1956, in 2008 and Under Section 12B of the same act in 2018.

The college was granted affiliation by the University in the academic session 2007-08 and subjects like **Arabic (Hons.), Bengali (Hons.) and Arabic (General), Bengali (General), English (General), History (General), Political Science (General) and Philosophy (General)** were offered.

We are grateful to the University of Calcutta for kindly granting extension of affiliation to subjects like **English (Hons.), Islamic History & Culture (Hons.) and Education (General)** to the college from the academic session 2008-09.

In 2009-10 Session the college has further obtained affiliation in **Philosophy(Hons), History (Hons) and Urdu (Gen)**.

The **College was included in the year 2012 under the West Bengal colleges (Payment of Salaries) Act, 1978. We are very grateful to the State Government.**

The College is located at **Jogibattala, Baruipur, South 24 Parganas (Kolkata - 700145), West Bengal**, just five minutes away from Baruipur Railway Station and one minute away from Jogibattala Bus Stand on the Baruipur-Garia Bus Route.

3. Applicability of the Regulations

These regulations shall be applicable to:

- a. The students who are taking admission to the B.A./B.Sc./B.Mus. (Honours/General) Course from the academic session 2018-2019.
- b. The students who were admitted in earlier sessions but did not enroll for B.A./B.Sc./B.Mus. (Honours /General) Part I Examinations up to 2018.
- c. The students who were admitted in earlier sessions and enrolled for B.A./B.Sc./B.Mus. (Honours/General) Part I Examinations but did not appear in Part I Examinations up to 2018.
- d. The students who were admitted in earlier sessions and appeared in B.A./B.Sc./B.Mus.(Honours/General) Part I Examinations in 2018 or earlier shall continue to be guided by the existing Regulations of Annual System.

ADMISSION REGULATIONS

- 4(a). A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission to the 1st year of the 3 year (six semesters) B.A. (Honours / General) Course of Studies provided he/she has also passed in English having full marks not being less than 100 and fulfills the conditions as laid down in **Clauses 5**.

Candidates who have passed the Higher Secondary (10+2) Vocational examination conducted by the West Bengal State Council of Vocational Education and Training shall be eligible to seek admission to the B.A. (General) 1st year Course of Studies taking the subjects under Humanities Division only.

However, no candidate shall be allowed admission after a lapse of more than 5 years from the year of passing the previous qualifying examination.

Explanation: The year of admission shall not be taken into account while calculating five years from the year of passing the previous qualifying Examination.

- (b). Students who have passed the Higher Secondary (10+2) Examination or its equivalent from the All India Boards/Councils (i.e. CBSE, ISC and National Institute of Open Schooling) need not require to submit Migration Certificate for getting Registration under this University.

5. For the purpose of determining eligibility for admission to the B.A.(Honours / General) Courses, aggregate marks shall be calculated by adding the marks in top-four subjects in order of marks secured by a candidate. Marks in compulsory Environmental Education/Studies shall not be taken into account for calculation of aggregate marks. However, if the subject "Environmental Science" is studied as an elective subject of 100 marks, it may be taken into account for the purpose of determining the aggregate marks.

- (a). **A candidate taking up Honours Course in a subject must have obtained :**

- i. A minimum of 50% marks in the aggregate and 45% marks in the subject or related subject at the previous qualifying examination [in case of B.Mus. (Hons.) 45% marks in the aggregate and 45% marks in the subject Music, in the previous qualifying examination]

Or

- ii. 55% marks in the subject or related subject at the previous qualifying examination [in case of B.Mus. (Hons.) 50% marks in the subject Music at the previous qualifying examination.]

Or

- iii. 50% marks in the aggregate when the candidate has not studied the subject in his/her previous qualifying examination provided all other clauses are satisfied [in case of B.Mus. (Hons.) - 45% marks in the aggregate when the candidate has not studied the subject Music in the pre-qualifying examination. Candidates shall be admitted on the basis of the Admission Test to be conducted by the College Authority concerned.]

- (b). Candidates belonging to Reserved Categories taking up Honours Course of Study must have obtained a minimum of 40% marks in the aggregate or 40% marks in the subject or related subjects at the previous qualifying examination, as the case may be.

6. Attendance

- 6.1. A student attending at least 75% of the total number of classes* held shall be allowed to appear at the concerned Semester Examinations subject to fulfillment of other conditions laid down in the regulations.

- 6.2. A student attending at least 60% but less than 75% of the total number of classes* held shall be allowed to appear at the concerned Semester Examinations subject to the payment of prescribed condonation fees and fulfillment of other conditions laid down in the regulations.

- 6.3. A student attending less than 60% of the total number of classes* held shall not be allowed to appear at the concerned Semester Examinations and he /she has to pursue admission to the same Semester in the very next year for attending the classes and appearing at the said Semester Examination.

**Such attendance will be calculated from the date of commencement of classes or the date of admission, whichever is later.*

7. Outline of Choice Based Credit System

A) Core Course (CC) : A course, which should compulsorily be studied by a candidate as a core requirement is termed as a Core course.

• **Modalities of selecting CC by a student of Honours/ General programme shall be as follows :**

- a) In case of B.A. Honours programme a student shall have to study 14 Core courses of the Honours Subject as specified for each of the 6 semesters.
 - b) In case of B.A. General programme a student shall have to study 4 Core Courses of each of the 2 chosen subjects as specified for each of the first 4 Semesters. In addition 4 Core Courses to be studied; two courses each from two language subjects: **LCC1-** English & **LCC2-** MIL (Bengali/Hindi/Urdu) /Alternative English as specified for each of the last 4 semesters.
- B) **Elective Course:** Generally a course which can be chosen from a pool of courses and which may be very specific or specialized or advanced or supportive to the discipline/subject of study or which provides an extended scope or which enables an exposure to some other discipline/subject/domain or nurtures the candidate's proficiency/skill is called an Elective Course.
- i) **Discipline Specific Elective (DSE) Course:** Elective courses which may be offered by the main discipline/subject of study is referred to as Discipline Specific Elective. This course is to advance knowledge and skill in the core course domain.
 - ii) **Generic Elective (GE) Course :** An elective course chosen generally from an unrelated discipline/subject, with an intention to seek wide exposure, is called Generic Elective.

Modalities of selecting GE by a student of Honours/ General programme shall be as follows :

- a) In case of B.A. Honours programme, a student shall have to choose 4 Generic Elective papers strictly from 2 subjects of choice taking exactly two courses from each subject as specified for first 4 semesters.
 - b) In case of B.A. General programme, a student shall have to choose 2 Generic Elective papers strictly from one particular subject [which will be different from the core subjects including the Core Languages (LCC1 & LCC2)] as specified for the 1st and 2nd semester.
- C) **Ability Enhancement Courses (AEC) :** The Ability Enhancement Courses (AEC) may be of two kinds: Ability Enhancement Compulsory Courses (AECC) and Skill Enhancement Courses (SEC).
- a) **Ability Enhancement Compulsory Courses (AECC) :** AECC courses are the courses based upon the content that leads to Knowledge enhancement. These are mandatory for all disciplines.
 - i) AECC1 : Communicative English / MIL (Bengali/Hindi/Urdu);
 - ii) AECC2 : Environmental Studies.
 - b) **Skill Enhancement Courses (SEC):** These courses may be chosen from a pool of courses designed to provide value-based and/or skill-based knowledge and are aimed at providing competencies, skills, etc.

Tutorial : Every Core, Discipline Specific and Generic Elective Course shall have a Practical/ Tutorial component. Wherever there is a practical, there will be no Tutorial and viceversa.

CANCELLATION OF ADMISSION / ENROLMENT OF STUDENTS & DISCIPLINARY ACTIONS

Admission of students is liable to be cancelled at any stage with the discovery of non-fulfilment of eligibility criteria, error in information, misconduct, indiscipline and violation of rules. The College shall not be held responsible for cancellation of admission.

Strong disciplinary actions like suspension, expulsion or issuance of transfer may be taken against a student for his such actions, or torts, that may damage the spirit and image of the College, or **break of peace and tranquillity or discipline of the College.**

If any student simultaneously pursues similar courses in any other institution during his/her study in this College, **his admission / registration of this College shall be cancelled.**

A student who shall be **found Reported Against in any Examination of the University shall be expelled from the College.**

If any student is found to be misbehaving or **involved in such actions that are wrought with evil intentions/ulterior political motives to damage the image of the College or pollute its environment, he/she shall be expelled from the College.**

If any student fails consecutively for two years in the same subject (Hons/subsidiary), he/she may be issued transfer from the College.

Or, any such action(s) by the student, that be deemed by the College authority as sufficient cause for expulsion/transfer of the student, he/she shall be expelled/transferred.

An undertaking shall be obtained from the student on the ground that he/she shall abide by the rules of the College.

Name of a student may be struck off the Rolls of the College, if his/her number of attendance falls shorter than what is expected, through **review at a regular interval of three months.** He/she may be debarred from the University examinations if his/her attendance is below 75%, or he/she shall be considered discollegiate as per the University Rules.

ACADEMIC SESSION

The academic session commences from 1st of July every year till the 30th of June of the following year like all other day colleges under the University of Calcutta. The college hour being from 10 a.m. to 5 p.m. normally.

MEDIUM OF INSTRUCTION

The medium of instruction is Bengali and English.

RULES FOR STUDENTS AND GUARDIANS

CLASSES AND ATTENDANCE: As per rules of the University of Calcutta, a student must attend a minimum of 75% of the total number of lectures delivered plus tutorial in each subject in order to become a regular student.

DISCIPLINE: The discipline of a College plays an important role in imparting good education among the students. The College, therefore, seeks co-operation of all students, guardians in the matter of strict observance of the rules of academic discipline. A student may even be expelled from the college on the grounds of violation of rules, indiscipline, misconduct and such other activities. Smoking, spitting inside the college premises, loitering on the corridor, shouting or screaming, use of mobile phones, etc. are strictly prohibited.

EXAMINATION: The college conducts examinations as per the Calcutta University instructions. Unit Tests and Class Tests are held in the college. Appearing in the unit tests and class tests are mandatory for students. To be properly informed about different circulars issued by the University, to be registered with the University on time, and to have information of the University Examinations and filling up of forms, etc, the students are asked to attend college regularly and get in touch with the college office. The College can not be held responsible on those matters for any lapse on the students' part.

TO FOLLOW THE NOTICE BOARD : Students must abide by every notice issued to them. They must follow the notice board regularly and carefully while entering and leaving the college. No excuse shall be entertained if the notices are ignored or overlooked.

SOME OTHER INFORMATION ABOUT THE COLLEGE

LIBRARY: The Library of the college is kept open for the students from 12p.m. to 3p.m. কলেজে লাইব্রেরী ব্যবহার করার সময় সকাল ১২টা থেকে ৩টা পর্যন্ত।

The students will be charged with fine for late in return of library books, for late in payment of monthly tuition fee, damage of any property of the college (the amount of fine will depend upon the extent of damage caused by the student), etc.

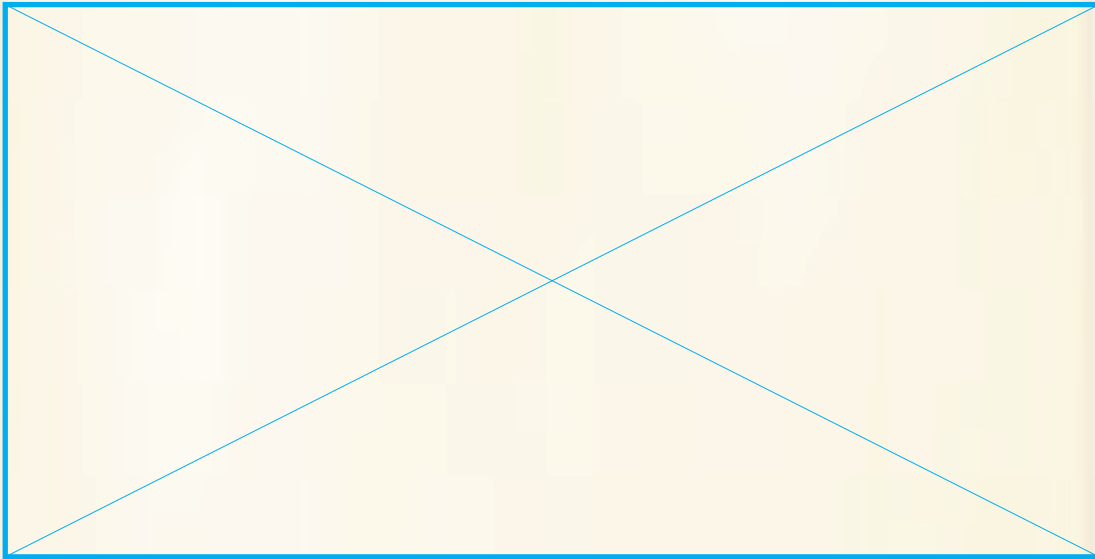

NATIONAL COUNCIL FOR PROMOTION OF URDU LANGUAGE

A Certificate in Arabic Language (One Year) and Diploma in Functional Arabic (Two Year) under National Council for Promotion of Urdu Language, Ministry of HRD Govt. of India, is offered in the college. About 300 students are doing this course and already 1360 students passed in last five years. Admission to this course is generally taken in January - February every year and the final examination is conducted in April in the following year. Computer courses under this council, and other technical and vocational courses will soon be introduced.
